Funds were awarded to PEC's Sprucepine Branch and Bolton Branch Trout Stream Restoration Projects. These projects reconnected over 4 miles of trout habitat by replacing culvert driveway barriers to fish passage with open-span bridges. Additionally, Bolton Branch restored 800 linear feet of stream bank and 1.5 riparian acres for water quality and habitat benefits. PEC coordinated with the U.S. Fish and Wildlife Service and Shenandoah Streamworks on the natural channel design and construction. The work included re-grading stream banks and in-stream structures that restored the natural hydrology of those streams.
